## **Diavik and Ekati Production Update**

On May 20, Dominion Diamond Corporation reported that rough diamond production, sales and pricing have all exceeded targets for the first quarter of fiscal 2015 (February through April) to the extent that the estimated value of the Company's production at current sales prices is ahead of expectation by approximately \$100 million. Information for Ekati and Diavik follows.

## **Ekati Mining Update**

The decision in the autumn of 2013 to accelerate the mining capability in the Fox pipe has resulted in an additional approximately 100,000 tonnes of material being mined from the open



pit ahead of the spring Freshet (snowmelt). This material was mined from a section of the ramp which was in kimberlite but was not part of the original mine plan. Mining at the Fox pipe was completed last week.

The development at the 1810 level at Koala Underground was completed at the end of February and production drilling commenced in March.

During the quarter, the Company tested a small kimberlite pipe within the Misery pit to the northeast of the main ore body which has been excavated as part of the Misery pushback. As a result of a bulk sample run on this material, approximately 30,000 tonnes of the Misery Northeast material has been stockpiled and will be processed in the second quarter. The characteristics of the diamonds in the satellite pipe material appear to be very similar to the diamonds from the Misery Main pipe.

#### **Diavik Mining Update**

Ore mined at the Diavik mine was 12% ahead of plan. This performance results from higher production from A-418 and A-154 South due to favourable ground conditions and improved availability of equipment.

#### **Ekati Processing Update**

The Company estimates that process plant improvements to date have increased the recovered grade during the first quarter by approximately 15%. Most of this incremental recovery is in smaller diamonds not currently included in reserves. Historically, Ekati has bypassed the recrush circuit in order to maximize process plant throughput and has not recovered the entrained diamonds within the coarse fraction of the tail rejects. The recrush circuit will likely be re-established by year-end to further improve diamond recovery. Once the process improvements have been substantially completed the Company intends to incorporate the higher recovery rate into an updated reserves statement.

#### **Diavik Processing Update**

Ore processing was 18% ahead of plan predominately due to greater ore availability as a result of higher mining rates and improved equipment availability, equipment efficiencies and utilization of the processing plant.

#### Q1 2015 Ekati and Diavik Rough Diamond Sales

The Company recorded total first quarter sales of \$175.5 million.

## Jay Project Update

The winter drilling, environmental and engineering program has revealed conditions that will accommodate a simplified design for the Jay Project allowing a reduced environmental footprint and a shortened construction timeline without sacrificing project economics. Regulatory agencies have now been advised of the revised project design and it will form the basis of the Developer's Assessment Report to be filed in September this year. It is this report that is the starting point for the Environmental Assessment.

## Baffinland a go: receives amended project certificate for Mary River Project

On May 28, the Nunavut Impact Review Board (NIRB) issued an amended Project Certificate to Baffinland Iron Mines Corporation to address the Early Revenue Phase proposal for the Mary River Project. The amended Project Certificate consists of 7 new terms and conditions and 45 revised terms and conditions intended to address the potential adverse effects of the Early Revenue Phase proposal, as approved by the Minister of Aboriginal Affairs and Northern Development on April 28, 2014.

The Mary River Project is located on Baffin Island in the Qikiqtaaluk Region, approximately 160 km southwest of Pond Inlet. Originally approved in 2012 following an extensive public review by the NIRB, the Mary River Project consisted of mining iron ore from the reserve at Deposit No. 1 at a nominal production rate of 18 Million tons per year (Mt/a) for an estimated 21 year mine life, with exploration, construction, operation, closure, and reclamation of an open-pit mine at Mary River and associated infrastructure for extraction, transportation by rail and shipment of iron ore using purpose built ore carriers with ice breaking capability. The Mary River Project consists of 3 main project locations – the mine site at Mary River, Milne Port north of the mine site, and Steensby Port south of the mine site. Milne Port is connected to the mine site by the pre-existing Milne Inlet Tote Road, whereas a railway would be constructed to connect the mine site to Steensby Port.

Following the issuance of the original Project Certificate for the Mary River Project, in January 2013 Baffinland applied to the NIRB for a formal reconsideration of the Project Certificate terms and conditions to reflect additional activities associated an updated development plan, incorporating the Early Revenue Phase proposal. The Early Revenue Phase proposal would allow for transport of up to 3.5 MT of iron ore north on the Milne Inlet Tote Road for annual shipment during the open water season from Milne Port.

The NIRB conducted an extensive public reconsideration process for the Early Revenue Phase proposal pursuant to Section 12.8.2 of the Nunavut Land Claims Agreement which included submission of an addendum to the Mary River Final Environmental Impact Statement by the Proponent, technical review and submission of written comments by parties, and facilitation of community information sessions and a public hearing in Pond Inlet. On March 17, 2014 the NIRB issued a public hearing report to the responsible government ministers, recommending that the Early Revenue Phase proposal should be approved to proceed pursuant to the additional and revised terms and conditions set out in the Board's report.

On April 28, 2014, responding on behalf of the various responsible ministers, the Minister of Aboriginal Affairs and Northern Development Canada accepted the NIRB's report, rejecting one term and condition and further varying 4 terms and conditions. Following receipt of the Minister's approval and prior to issuing the amended Project Certificate, the NIRB facilitated a Project Certificate Workshop to discuss implementation of the Project Certificate terms and conditions and determine whether any additional commentary would be necessary.

An Inuktitut translation of the amended Project Certificate is being prepared and will be distributed as soon as it becomes available.

The NIRB looks forward to further developing its monitoring program for the Mary River Project and will be providing regular updates on the implementation of the Mary River Project Certificate moving forward.

## Meliadine Ramp Development, Exploration and Permitting Activities Continue

Agnico Eagle reports in their Q1 news release that underground development, exploration, technical studies and permitting have continued in the first quarter of 2014 with \$9.9 million in capital expenditures at their 100%-owned Meliadine gold development project near Rankin Inlet, Nunavut.

The Meliadine project has the Company's largest and fastest-growing high-grade complement of reserves and resources. (See the Detailed Mineral Reserve and Resource Data in the Company's February 12, 2014 news release.)

Late in 2013, a permanent portal was completed for the existing exploration ramp north of the Tiriganiaq zone, and the ramp was extended by 80 metres. Ramp development continued in the first quarter of 2014, adding 226 metres. The full-year budget calls for approximately 1.4 kilometres of ramp development (to a depth of 275 metres below surface).

Three drill rigs are active on a surface drill program, which began in late February, one month ahead of schedule. The rigs completed 27 holes (7,107 metres) of conversion drilling (Wesmeg/Normeg zone) and exploration drilling (Wesmeg/Normeg and Pump zones) to the end of March. Additional condemnation/geotechnical drilling in an area of proposed mine site facilities is also planned. While no results are available yet, significant new gold mineralization was discovered in the western extension of the Pump zone, showing its potential to host additional high-grade resources. In March the underground delineation drill program began, using one rig at 75 metres depth. This program is helping to refine the geological model of the Tiriganiaq zone.

Work continues on the updated technical report, scheduled for completion in late 2014. The permitting team is preparing documents for the Final Environmental Impact Statement (FEIS), with a target completion date in the second quarter of 2014.

## TMAC Raises Financing and commences 2014 Hope Bay Programs

On May 1, TMAC Resources Inc. announced the successful completion of a private financing to raise \$78 million to be used by TMAC at its 100% owned Hope Bay Gold Project located approximately 685 kilometres northeast of Yellowknife in the Kitikmeot region of Nunavut. The moneys will fund its 2014 program which includes exploration, engineering, environmental permitting and compliance, a pre-feasibility study and for working capital and general corporate purposes. Coincident with the closing of the financing, the Company repaid the \$15 million dollar convertible loan plus interest owed to Newmont Mining Corporation, which was scheduled to mature on December 31, 2014.

On May 13, TMAC announced they had approved a plan and budget for 2014 totalling approximately \$61 million to advance the Hope Bay Gold Project. That Plan and Budget, which commenced April 1, 2014, consists of exploration, engineering, environmental permitting and compliance and completion of a pre-feasibility study.

Terry MacGibbon, TMAC's Executive Chairman stated, "This financing clearly demonstrates the strong endorsement by investors of the quality of Hope Bay and the strength of the Company's management team and its operating philosophy. We are very pleased that TMAC, a private exploration and mine development focused company, has been able to raise over \$110 million of equity since being incorporated and acquiring Hope Bay in March 2013. We are also very pleased to welcome Resource Capital Fund, along with Newmont and the Inuit of Nunavut, as partners in the further development of Hope Bay." He added, "This financing, along with our current funds, after the loan repayment, leaves approximately \$72 million in the Company's treasury. Pending 2014 results, the Company plans to conduct a pre-feasibility study by early 2015, which, when completed, will allow the Company to consider equity and debt project financing options.

TMAC is a privately held mineral exploration and development focused company with an experienced and accomplished board of directors and a strong senior management team, which includes a number of former senior executives of FNX Mining Company Inc. ("FNX") and headed by Terry MacGibbon, founder of FNX Mining Company Inc. and co-founder and Chairman of Torex Gold Resources Inc. TMAC's management team has an exceptional track record of discovering, defining and developing high grade, profitable underground mines.

## Peregrine Reports new resource for Nunavut diamond deposits

On May 07, 2014, Peregrine Diamonds Ltd. announced estimates for a maiden independent Canadian National Instrument ("NI") 43-101-compliant Inferred Mineral Resource for the top 250 metres of the CH-6 kimberlite pipe and additional tonnage as a target for further exploration.

Key elements of the CH-6 estimates are:

- An Inferred Mineral Resource of 7.47 million carats of diamonds in 2.89 million tonnes of kimberlite to a depth of 250 metres;
- Grade of 2.58 carats per tonne;
- An average diamond price of US\$213
   per carat and a modelled price range
   between US\$163 and US\$236 per
   carat as determined by WWW
   International Diamond Consultants
   in February 2014;

- An estimate of 2.60 to 3.47 million tonnes of kimberlite classified as a target for further exploration;
- The kimberlite is open at depth.

Tonnage estimates have been completed for the CH-7 and CH-44 kimberlites. The CH-7 kimberlite tonnage estimate is between 2.75 and 3.97 million tonnes from surface to a depth of 280 metres. The CH-44 tonnage estimate is between 1.16 and 2.05 million tonnes from surface to a depth of 230 metres. Both CH-7 and CH-44 are open at depth.

The CH-6, CH-7 and CH-44 kimberlite pipes are located on Peregrine's 100 percent-owned Chidliak project ("Chidliak"), 120 kilometres from Iqaluit, the capital of Nunavut, Canada.


## **Diavik releases 2013 Sustainable Development Report**

## Selwyn project update

The Selwyn Project is under new management and continues to advance. In April of 2013 Selwyn Chihong Mining Ltd bought out the remaining 50% of the Selwyn Project from their JV partners, Selwyn Resources Ltd. The new owners are making a significant investment in advancing the project in 2014. They have committed \$56 million to the project this year focusing on infill, exploration, and geotechnical drilling, engineering and environmental studies, and continued incremental infrastructure development.

Encouraged by the shifting investment and regulatory climate in the NWT, the company has committed over \$14 million of the total budget to drilling and road construction in the Territory. Selwyn Chihong holds over 5,000 hectares of mineral leases in the NWT. In addition, the preferred access route of the Project runs for 80 km through the Territory. This planned program marks the first significant exploration investment on these properties since they were first developed and explored in the 1970's.

Starting this past winter, Selwyn Chihong began a program of road rehabilitation on the access road. The company has already invested almost \$7 million on bridge replacements and intends to invest a further \$4 million on road improvements over the summer.

The company also intends to complete 1,000 metres of exploration drilling on its mineral leases in the NWT this summer. These mineral leases are connected directly to the XY mineral claims

Drilling completed on these leases in the 1970's provided positive indication of mineralization consistent with the XY deposit.

Selwyn Chihong has Cooperation Agreements in place with NWT communities and has been working through these agreements in order to maximize local benefits from the ongoing work. To date, roughly 70% of the current expenditures in the NWT have been committed to local contractors and suppliers. Selwyn Chihong is committed to maximizing local benefits and developing local capacity for future work on the project.

## Tłıcho Government Files Court Challenge to Amendments to the MVRMA

Grand Chief Eddie Erasmus announced on May 8 that the Tłıcho Government has filed a court challenge of Canada's recently enacted amendments to the *Mackenzie Valley Resource Management Act* ("MVRMA").

The MVRMA amendments were passed by Parliament on March 25, 2014 as part of Bill C-15, the *Northwest Territories Devolution Act*. The T<sub>1</sub>cho legal action claims that parts of the legislation, which attempt to dismantle the Wek'èezhìi Land and Water Board, breach of the T<sub>1</sub>cho Agreement and the honour of the Crown and unjustifiably infringe T<sub>2</sub>cho treaty rights.

Wek'èezhìi, which lies at the heart of the traditional territory of the Tłıcho, is the recognized area for land and water management set out in the Tłıcho Agreement. The Wek'èezhìi Land and Water Board makes land and water decisions in the region with equal representation from Tłıcho and Canada's appointees. It fulfills a key constitutional promise to the Tłıcho within the Tłıcho Agreement.

"We will protect Wek'èezhìi for as long as this land shall last. We can only do that if we are decision-makers and stewards in relation to Wek'èezhìi, today and into the future. Canada cannot simply ignore its constitutional promises to our people. We won't allow it and its truly upsetting that we are forced into the courts in order to uphold the Crown's honour," said Grand Chief Erasmus.

Since its creation over a decade ago, the Wek'èezhìi Land and Water Board has been recognized as a success by local communities, industry and Canada itself. It has incorporated Ticho traditional knowledge and perspectives into its decision-making and was recently awarded the 2014 Council of the Federation Excellence in Water Stewardship Award. Yet, despite its success, Canada has chosen a path that attempts to destroy this important institution, an institution that is fundamental to the Ticho Agreement.

"The Tłıcho Government rejects Canada's unilateral approach," added Grand Chief Erasmus. "We are Canada's treaty partner. We thought the days of the government in Ottawa thinking it 'knows best' about our lands, resources and future were over when we signed the Tłıcho Agreement. We won't go back to the days when outsiders made decisions about our future and that of Wek'èezhìi."

The Tłıcho Government is the governing authority within Tłıcho lands responsible for managing the rights and benefits provided under the Tłıcho Agreement. The Tłıcho Government has the power to pass and enforce its own laws, and has authority over the use, management, administration and protection of Tłıcho lands and renewable resources.

## **Conference Board's Economic Report Card highlights North**

The Conference Board of Canada has launched a website that provides a report card of their assessment of Canada's quality of life compared with that of its peer countries. The Board looks at Canada's national and provincial performance relative to that of 15 other peer countries in six performance categories: Economy, Education and Skills, Innovation, Environment, Health, and Society.

The website is titled **How Canada Performs: A Report Card on Canada**, and some highlights of their report card include:

- Resource-rich Alberta, Saskatchewan, and Newfoundland and Labrador are the top performers among all the provinces and international peers—all three provinces score "A+" grades on the Economy report card.
- New Brunswick and Nova Scotia are at the back of the pack, with "D" grades overall.
- Most provinces, and Canada, are middle-of-the-pack performers, scoring high on some indicators but well below average on others.
- The territories, particularly Yukon and Nunavut, outperform most of the provinces on several Economy indicators.
- Alberta, Saskatchewan, and Newfoundland and Labrador score top grades in the latest Economy report card. Most provinces are middle-of-the-pack performers.
- Productivity is the single most important determinant of a country's long-term prosperity. Canada and most provinces get "C" grades on labour productivity growth and Canada's productivity gap with the U.S. continues to widen.
- Overall, Canada gets a "B" grade on the Economy report card, ranking 5th among the peer countries, and 8th overall. While Canada's overall "B" is good, there is definitely room for improvement.

The report card provides the following comments on the NWT, Yukon and Nunavut:

- The Northwest Territories and Yukon have earned either "A+", "A" or "B" grades on per capita income since the beginning of the 2000s. In fact, per capita income in the N.W.T. has been well above that of every Canadian province since the beginning of the 2000s, when data on the territory as separate from Nunavut started to become available.
   N.W.T.'s strong resource base, including diamonds as well as oil and gas, is the catalyst for its strong economy.
- Yukon's economy is also largely resource based. Per capita income in Yukon has been above that of all provinces except Alberta since the mid-1980s.
- Nunavut's per capita income is below levels in both the Northwest Territories and Yukon, but is still high by Canadian standards, surpassing the Canadian average in 2010, 2011, and 2012. Its economy is not as developed as the other two territories and, consequently, Nunavut's overall GDP lags behind.



• The economic outlook remains positive for the territories over the next few years. Mining will be one of the most important economic drivers in Northern Canada in the years ahead. Several new mines are slated to open before the end of the decade in Nunavut, Yukon, and the Northwest Territories.


## Territorial Economic Outlook good says Conference Board of Canada

The Conference Board of Canada's recently released *Territorial Outlook: Economic Forecast* indicates that while the mining industry will continue to be pressured by commodity prices, the economic outlook for Canada's three Northern territories is positive:

- Nunavut Poised for More Balanced Growth: The Mary River iron ore project and a number of public infrastructure projects will generate new jobs for Nunavut over the near term.
- Big Projects are on the Horizon in the NWT: The composition of growth in the NWT economy is changing as the diamond industry matures.
- Yukon Investment Rebound to Boost Growth: While the economy is still facing headwinds, the near-term outlook is looking generally more positive.

The report provides the economic and fiscal outlook for each of Canada's three Northern territories, including output by industry, labour markets, and demographics.

## Community Training in Action: Mine-Related Training in Arviat, NU

On March 14, 2014, the Hamlet of Arviat celebrated the graduation of the first class of the Arviat Welding Trade Readiness Program. This 8-week program taught basic cuts and welds, safety, tool operation & maintenance, and blueprint reading. Developed with the support of Agnico-Eagle Mines Ltd. and the Kivalliq Mine Training Society, the Arviat Welding Trade Readiness Program is the latest training program the Hamlet of Arviat has offered to residents to open doors for Arviammiut in the mining industry.

Welding skills are always in high demand, and Agnico-Eagle Mines Ltd. committed to hiring three of the seven graduates. The Hamlet hopes that this program will not only allow students to work as welders or welder's helpers, but also go on to skilled trades such as Heavy Duty Equipment Mechanics and Millwrights – both in high demand in the mining industry.

From an economic development perspective, the mining industry in Nunavut has great potential for residents of Arviat. The Kivalliq



is home to Nunavut's only operating mine at Meadowbank, and with the Meliadine and Kiggavik Projects hopefully moving into production in the near future, mining is a great opportunity for employment and businesses in the region. Realizing this potential, in recent years the Hamlet of Arviat has largely focused their economic development activities on minerelated training to help Arviammiut take advantage of these opportunities.

In 2011, the Hamlet of Arviat partnered with Northern College of Kirkland Lake, Ontario, to offer a Surface Diamond Driller Assistant Common Core program. With the support of industry (particularly Agnico-Eagle Mines, Ltd., and drilling companies Boart-Longyear and Forage Orbit-Garant), government, and NGOs, the Hamlet purchased a surface diamond drill and equipment so that Arviat residents could complete this course at home. To date, the Hamlet has completed four intakes of this program, training 43 people as Surface Diamond Driller's Helpers for this entry-level but skilled position. A fifth intake is currently underway.

In response to industry requests and again in partnership with Northern College, the Hamlet of Arviat began offering a 3-week Work Readiness Program in 2013. This program prepares students for employment or continuing education by focusing on employer expectations, conflict management, personal goal setting, and interpersonal skills. This program has been very successful in getting Arviammiut motivated to successfully pursue employment and further educational opportunities.

Following on these successes, the Arviat Welding Trade Readiness Program is the latest program to be offered by the Hamlet of Arviat. Partners in our training programs have included the Government of Nunavut, Kivalliq Mine Training Society, Northern College, Nunavut Arctic College, Agnico-Eagle Mines, Ltd., Boart-Longyear Drilling, Forage Orbit-Garant Drilling, Kivalliq Partners in Development, and the Kivalliq Inuit Association.

While the Hamlet of Arviat recognizes that one of our community's greatest assets is its traditional skills and knowledge, it also recognizes that our large, young, and rapidly growing population is going to dramatically increase the demand for employment in the near future.



## **NWT Diamond Production Update**

A glimpse at the history of diamond productions statistics from the Northwest Territories reveals the growth of production from our first mine EKATI, to Diavik and then Snap Lake. Production numbers reveal why we call EKATI and Diavik world class deposits. Taken toether, the three diamond mines have elevated the NWT to third place in the world by value of production. Note that diamond value is not always linked to production and reflects how different sizes and qualities of diamonds vary in demand and the prices received.



## **NWT Devo: Three more Aboriginal groups sign on**

Three more Aboriginal groups – Acho Dene Koe First Nation (ADK) and Fort Liard Métis Local #67, Deninu K'ue First Nation (DKFN) and the Salt River First Nation (SRFN) – became parties to the Northwest Territories Devolution Agreement during a signing event at the Legislative Assembly in Yellowknife on May 26.

"This is a good time for us to sign on to this Devolution agreement," said ADK Chief Harry Deneron. "We are speaking for Fort Liard, and for us, a lot has changed. We have reached an Agreement-in-Principle, and we are ready to move forward."

"The signing of the Devolution Agreement is a positive step for Deninu K'ue First Nation. It will enable us to be more self-sufficient and create employment to improve the future for our youth," said Chief Louis Balsillie. "The Devolution Agreement opens the doors for Deninu K'ue First Nation to finally benefit from the resource development occurring within Akaitcho Territory and across the Northwest Territories."

"This is a historic day for the Salt River First Nation. The signing of the Devolution Agreement has been a work in progress, and today we are accomplishing our Salt River First Nation mandate as a separate entity with the Government of the Northwest Territories," said Chief Frieda Martselos.

"Now that devolution has been implemented, it remains important to the Northwest Territories that Aboriginal governments are able to participate and benefit," said Premier McLeod. "I am very pleased to have the Acho Dene Koe First Nation and Fort Liard Métis, the Deninu K'ue First Nation, and the Salt River First Nation join as parties to the agreement".

With today's announcement, the ADK and Fort Liard Métis Local #67, the DKFN and the SRFN will join the Inuvialuit Regional Corporation, NWT Métis Nation, Sahtu Secretariat Incorporated, Gwich'in Tribal Council and TłįchQ Government as parties to devolution along with the Governments of Canada and the Northwest Territories. This represents a majority of northern Aboriginal land claim groups that have now support devolution.

Stephanie officially moved into her new role on May 5th. We congratulate Stephanie! Her strong background in HR will serve the facility and our industry well.



## Chamber supports New Naats'ihch'oh National Park as Reasonable Balance

In 2012, the Chamber of Mines expressed its support for the establishment of the Naats'ihch'oh National Park Reserve in the Sahtu Region of the western Northwest Territories The Chamber is pleased to support Federal Bill S-5 introduced on May 14 in the Senate of Canada to formally establish the park.

The Mineral and Energy Resource Assessment completed by the Geological Survey of Canada (GSC) as part of the park establishment process documented many areas of significant mineral potential within the Mackenzie Mountains Cordillera, the region that surrounds and includes the Naats'ihch'oh Park Reserve area. The GSC's work was taken into account by the Government of Canada in making the final boundary decision.

"As we said when the Prime Minister announced Naats'ihch'oh in 2012, the Chamber of Mines supports the development of park boundaries that exclude known resource-rich areas so that northerners and all Canadians might take full advantage of future economic opportunities," said Chamber President Brooke Clements. "We are pleased that the significant mineral potential documented under the GSC mineral assessment has been taken into account in the boundary selection, and that the Minister is authorized to provide road access through the park to access resources in the future. Non-renewable mineral resources are the anchor of the



NWT's economy, and will provide socio-economic opportunities for future generations."

Naats'ihch'oh complements and adjoins the already established Nahanni National Park Reserve. Together they create a contiguous 35,000 square kilometre national park, one of Canada's largest. The park was established to protect the unique environmental, wildlife and geographic values of the Nahanni watershed.

## **AREVA Completes Winter Haul to Kiggavik Project Site**

The winter haul in preparation for AREVA's 2014 summer field exploration program at the Kiggavik Project began on March 12 with Peter's Expediting Limited (PEL) breaking trail.

The haul started with the transport of five "Seacan" containers full of drilling and camp supplies to the Kiggavik site. During the return trips from Kiggavik to Baker Lake, PEL brought back four containers containing scrap materials and one trailer with used drill rods. This material will be sent to licensed disposal sites in the south during the upcoming open water barge season.

PEL then began hauling fuel to the site. About 100,000 liters of Jet A fuel along with 110,000 liters of diesel fuel was transported to the AREVA fuel cache and pumped into large Envirotanks.

A good trail was established and the haul was going well, but with the warmer weather fast approaching PEL thought it safer to request some help to complete the fuel haul in good time.

M&T Enterprises from Rankin Inlet responded to the call and was able to bring its equipment to finish the fuel haul and transport the remainder of the drill supplies, such as core boxes, core racks, and bundles of drill rods.

The final trip of the winter haul took place on April 27 with a load of drill rods. In total, there were 16 trips consisting of 30 loads of freight transported to the Kiggavik Site in just over six weeks.

Thanks to the successful winter haul, the site will now be ready for the summer exploration field season to start in early June. (excerpted from Areva Resources Community Update, May 2014)


#### NWT's own rare earth elements are critical raw materials for the EU

Heavy rare earth elements (REE) rated highest as a critical raw material in the European Union's recently released *Report on Critical Raw Materials for the EU*, which deems some 20 raw materials fundamental to Europe's economy, essential for maintaining and improving quality of life, but where supply is somehow limited. Securing reliable and undistorted access of certain raw materials is of growing concern within the EU and across the globe. Light REE are also high on the list.

The conclusion that can be drawn from this analysis is that a rare earth supply chain outside China is still required, as China's monopoly still presents a significant supply risk for consumers in the EU.

This bodes well for the NWT's own REE Nechalacho deposit which Avalon Rare Metals is advancing to become a mine. Heavy REE are its economic advantage.

## Report: Confusion over duty to consult obstructs benefits for Aboriginal peoples

Prof. Dwight Newman debunks myths about the legal doctrine and finds opportunities for government, Aboriginal peoples and industry to work together

The Macdonald-Laurier Institute has released a new report addressing the duty to consult. Few Aboriginal issues have been as greatly misunderstood as the constitutional "duty to consult" doctrine.

Some feel the principle that requires governments to consult with Aboriginal groups before implementing decisions that might affect them gives First Nations a veto power over government policies. Others contend that the doctrine is meaningless because governments have the power to go ahead and approve projects anyw ays. These interpretations are not only incorrect, they also hold these groups back from capitalizing on Canada's potential, according to a new report from the Macdonald-Laurier Institute titled "The Rule and the Role of Law: The duty to consult, Aboriginal communities, and the Canadian natural resource sector".

The report, by Canada Research Chair in Indigenous Rights in Constitutional and International law Dwight Newman, argues that governments, Aboriginals and businesses should use the doctrine as a mechanism to work collaboratively on natural resource development.

"Canada's massive resource potential, and its potential to contribute to Aboriginal Canadians, should not be squandered by allowing loud voices to dominate discussions while trading in misunderstandings", he writes.

One of the main issues plaguing the duty to consult, which first came into effect as a result of a Supreme Court decision a decade ago, is the confusion over how it affects policy decisions. Many feel that Aboriginal groups will wield a narrow interpretation of the case law built up around the doctrine to consistently block resource development, highlighting disputes such as anti-fracking protests in New Brunswick or legal confrontations over the Ring of Fire in Ontario. That's despite the fact that many Aboriginals, such as members of the Fort McKay First Nation in Alberta, have expressed a desire to participate in resource development as long as their interests are represented.

Newman argues that governments, Aboriginals and businesses should use the doctrine as a "lever" that causes them "to come to an agreement over resource projects that benefit all parties". This means interpreting the duty to consult in less technical ways. History has shown that narrow interpretations of the doctrine aren't particularly beneficial, he says. "Those who attempt to draw upon the spirit of the duty to consult may well attain better outcomes than those who attempt to follow the letter of the law", Newman writes.

The courts also have a responsibility for ensuring that the doctrine functions smoothly, Newman argues. He believes that judges need to be very cautious in expanding the duty to consult because that will limit governments' flexibility in implementing policies, such as approving energy pipelines that affect Aboriginal communities. He also cautions that extending the duty to consult to drafting legislation, especially at the federal level with more than 600 First Nations, Inuit and Métis communities potentially impacted, would seriously complicate

law making and have unintended consequences that may actually work counter to its purpose of improving life for Aboriginal Canadians.

A proper understanding of the duty to consult has grown in importance since Shawn Atleo's resignation as the chief of the Assembly of First Nations last week. Divisions within Aboriginal communities, such as the varying opinions on education issues within the AFN that caused him to step down, will potentially make it more difficult for governments to carry out their duty to consult in the future.

"The prospect of the kind of less coherent approach to consultation urged by more radical voices carries serious risks of blocking important, badly needed reforms that are in the interests of First Nations children", wrote Newman in an op-ed published in the Globe and Mail earlier this week.

Dwight Newman is the Canada Research Chair in

Indigenous Rights in Constitutional and International law at the University of Saskatchewan. His new book, Revisiting the Duty to Consult Aboriginal Peoples, is set to be released by Purich Publishing in May.


